# Child Care Changes in Iowa

Local child care providers received a letter from DHS outlining the changes that take effect September 30, 2016. Due to these changes, it is perceived that some providers will no long be registered. Additionally, there is concern as to who and how the content areas will be delivered.

# Legislative Update

SF2299 is the ECI bill that is in regards to language cleanup to Early Childhood Iowa, additionally it will eliminate the categories. One change to the bill is the senate committee reverted the 5% to 3% on administration funds. This isn't a deal breaker for ECI.

# **Areas of Improvement**

- Quality child care, losing providers
- Not enough child care for the population
- Child care programs are not accepting CCRR services
- Retail leakage
- No grocery store in Adair County is open on Sunday (except for the one in Stuart)
- Getting involvement from parents such as attending education classes
- No urgent care, but do have a walk-in clinic

## **Adair County Health Systems**

- The hospital has contracted on a 6 month trial period with the CEO from the Madison County Hospital.
- Outpatient therapy for senior citizens is now available.

## **Adair County Extension**

- There will be no DCAT funding for the next two years. There will be standard \$20,000 in Community Partnerships for Protecting Children next year.
