- American Lung Association had a fundraiser and met their goal of \$350,000. ALS is sponsoring a Lung Force Expo for nurses, patients and care givers, scholarships to attend are available. ALS conducted an assessment with child care centers in Adair, Dallas, Madison, and Warren County and the following responded 7/14 in Adair, 20/64 in Dallas, 5/30 in Madison 28/99 in Warren County. Early Childhood Updates/Information

- Legislative update Public schools will be given flexibility with their categorical funds. Local ECI areas will have flexibility with their categorical funds. A Co-guardianship bill will be implemented. The Central Slice ECI areas provided for a day on the Hill April 4 with several legislators in attendance.
- Visiting Nurse Services will be having a lunch and learn at the May 25, 2017 meeting directly after the Dallas County Coalition meeting.
- Early Childhood Iowa has requested that local ECI areas conduct a core services assessment in each county. The intent of the assessment is to identify the perceived level of service for service types. The group assisted with the assessment and the data will be entered on behalf of the 4 R Kids ECI.

Dallas County Children's Advocacy Council Updates/Information

- The 1st fundraiser will by July 22 from 5:30-9:30 at Penoach Winery.
- Prevent Child Abuse Awareness activities 1200 grocery bags from Hy-Vee and Fareway, proclamation signed by the Dallas County Board of Supervisors, banner on the courthouse lawn, letter to editor, and press releases in newspapers.
- Prevent Child Abuse Iowa has provided local councils with FY18 contract renewal information. DCCAC will receive the same about of funding as FY17. A new reporting system will start in July utilizing the DAISEY system which aligns with Early Childhood Iowa.
- A presentation about child abuse was provided to the Perry Kiwanis April 18, 2017 with 9 in attendance.
