Health Navigation – Dallas County Public Health has received \$55,000 grant funding to support the Health Navigation program.

QIP – The Quality Child Care project with Dallas County Extension noted they have completed 37 crib exchanges with local providers supported by United Way Women's Leadership, approximate grant value in excess of \$20,000. The old cribs are being repurposed into different items and it would be great a 4-H project.

Partners in Family Development – PFD with the Parents as Teachers program for the Family Support Peer mock peer review. It is anticipated that PFD will earn the credential during FY2013.

CCNC – Chris updated the group that she has completed the necessary training and is now recognized by the state as a child care nurse consultant.

Training – CCRR will be providing Nurturing Healthy Sexual Development training for child care providers July 21 from 9:30-11:30 in at the Adair County IS Extension office.

4 R Kids Update – The 4 R Kids ECI area board has announced FY2013 grant awards in excess of \$1,000,000. Agencies and programs are as follows; Partners in Family Development for Parents as Teachers, Dallas County Public Health for Maternal Child Health, and New Opportunities for child care nurse consultant, Dallas County Extension for child care quality project and preschool enrichment. There will also be a contractor meeting July 16, 2012 at 1:00 at the Madison County Extension office.

Lutheran Services in Iowa – LSI is advertising for a full time family support worker to serve Dallas and Adair County. **Transportation** – Jeremy Johnson-Miller provided the group with an overview of the transportation services offered by HIRTA. Transportation to for Iowa Cares patients to Broadlawns in Des Moines can be arranged at a low cost of \$2.00. **Iowa Cares** – Iowa Cares information was disseminated.

Local Statistics – Living wage and population statistics were disseminated.

Prevent Child Abuse – The Dallas County Child Advocacy Council will receive \$45,250 for child abuse prevention programming.

ACES Summit – Shirley provided an overview of the ACES (Adverse Childhood Experiences) summit held in Des Moines. A follow-up in Dallas County is August 21 from 10-12 at the Adel Library.
