UHC has come out with a new product for those that are dually enrolled in Medicare and Medicaid and is piloted in a few counties in Des Moines metro, Warren, Dallas and Madison County are included as well as Story, Polk Marshal, and Jasper County. They are the only ones in the state with this product and it makes no difference which MCO the client is enrolled with. The service will provide up to \$1,000 annually for oral care, eye and ear care items, pain relievers, cold remedies and vitamins, thermometers, blood pressure monitors and more.
