Announcements and Information

New Parent Program - LSI announced they will be going through Healthy Families National Accreditation August 27-29, 2014. **Shared Visions -** The Department of Education has released an RFP for FY16. This is the first completive RFP since its inception.

Preschool definitions - The Department of Human Services and the Department of Education preschool definitions were discussed.

Child Abuse Awareness - The Warren County Child Abuse Council is conducting many child abuse awareness activities for April. There is also a u-tube video that PCA has done that would be a great addition.

There is concern if there will be reliable data for the annual report.

FY15 RFR - The 4 R Kids ECI Board released the request for renewal application to current contractors, this is the last year of a three year contract. In FY16 a competitive RFP will be issued.
