# Legislation

### **State Committee**

## **CBCAP Grant**

DHS announced the CBCAP grant awards and the Indianola Cluster was awarded \$4,127 a year for three years (FY17-Fy19. Funds will be used for the Young Parents group in Warren County.

### **Child Care Data**

The group discussed the FY15 CCRR data sheets regarding child care. Additionally, child care data was gathered on Adair, Dallas, Madison, and Warren County for comparison. Warren County has 81% of families with both parents working with child under the age of 6, the state rate is 75%. The average weekly income for Warren County families is \$1,434 and 14% of their income- before taxes - is expended on child care in a DHS licensed center. Also reviewed was Child Care Aware data that compares Iowa to other states. Data of interest is 43% of parents request infant/toddler care compared to the US at 40.7%. Average annual income of a child care worker is \$18,540 compared to the US at \$21,710.
