#### Early Childhood Updates/Information

- The 4 R Kids ECI Area board will release the FY19 request for proposal application March 16th with a due date of April 20, 2018.
- The proposed FY19 Dallas County Coalition meetings dates were reviewed by the committee. The dates mirror FY18.
- The collaborative project with the MCO's and referring families to ECI funded family support programs is being implemented through the current coordinated intake. The goals are to have a concrete referral source to serve high risk mothers, increase the number of families that are served prenatally, and to have better birth and health outcomes with an at risk population.

- The Prevent Child Abuse Iowa request for proposal has been released by DHS and DCCAC call apply for up to \$69,000. If agencies are interested in applying for funds, send a letter of intent to Joy by March 2, 2018. Areas of concentration will be sexual abuse prevention, parent development, and community development. Information will be sent to interested bidders on March 5th and will be due by March 13th. If no letters of intent are received, DCCAC officers will reach out to providers to see of their interest.

The American Lung Association holds the Community Partnership grant funded by the Iowa Department of Public Health, Division of Tobacco Use Prevention & Control for eight counties in Iowa. We serve Adair, Dallas, Jasper, Madison, Marshall, Polk, Union, and Warren Counties and follow best practices for tobacco control outline by the CDC:

- 1. Prevent the Initiation of tobacco use among young people
- 2. Eliminate non-smokers exposure to secondhand smoke
- 3. Promote quitting among young people and adults
- 4. Identify and eliminate tobacco-related disparities among population groups.

## Tobacco & Nicotine-free Worksites: Goal 4/2 \*\* Completed

- ✓ 2 worksites implemented a comprehensive policy.
- ✓ Still waiting on written confirmation from two more worksites
- ✓ Goal is already met, but we are still reaching out to new worksites and following up.

## Smoke-free Multi-Unit Housing: Goal 0/3 \*\* Pending

- ✓ Surveyed 32 properties regarding smoking policy
- ✓ 2 were interested in implementing a policy
- ✓ A strong lead for a smoke-free policy
- ✓ 1 more potential lead in the works
- ✓ Are you working with a client who complains of smoking in their building? If so, the client/customer can call the American Lung Association who can then assist the property with a smoke-free policy.

## Healthcare Provider Quitline Iowa Training: Goal 5/6 \*\* Pending
