## Introductions

**Legislation** - Governor Reynolds has signed an executive order to create a new children's mental health board in Iowa and Early Childhood Iowa is named as a board member. The session as yet to adjourn yet and there has been nothing released in regards the health and human services budget bill. ECI is expected to have the same amount of funding as FY18.

**Running for Office** - Deb provided the group with a handout of all of those running for the Iowa Legislature in the 4 county area with contact information. It is also on the 4 R Kids website.

**hawk-i** - New guidelines for dental and health insurance have been released, for example a family of 4 can make up to \$75,802 and be eligible for no more than \$40 a month.

CCRR Presentation - Child Care Resource and Referral provided a presentation regarding the changes effective July 1, 2018 with services. CCRR will now take over the work DHS used to do in regards to assisting child care providers get registered as well as assisting child care providers to take child care assistance. Referrals for parents will be centralized with one 800 number for the whole state. Much of the other services remain the same. QRS will change to IQ4K with implementation January 2019. There was no increase in funding for the new services.

Mothers and Baby Study - Partners in Family Development provided an overview of the Mother and Babies curricula.

**Warren County Human Service Coalition** - Continuation of discussion around having a human services coalition. It was suggested to get input from the Wellness Coalition.

**ECI Summit -** The ECI Summit is scheduled for October 3, 2018 and there will be tract for business/economic development. Local ECI boards are encouraged to work with economic development to get them to attend. Only those in the business world can attend the tract for business, no ECI directors are allowed to attend.
