American Lung Association

Samra Hiros from the American Lung Association gave an update on tobacco control activities in Adair County. Samra shared that the Iowa Youth Survey (IYS) 2018 results came out recently, but only had the state level data to share. County data will be available soon. Last fall, the FDA declared teen vaping an epidemic, and the IYS shows an increase in teen vaping. All middle and high schools in Adair County were provided resources on e-cigarette use for parents, teens, and educators. Samra also brought Quitline Iowa bags with information inside asking the coalition to share them in a break room, or front office area.

Legislative Update

Deb shared information on several bills that made funnel. SF438 is of particular concern as it strikes reporting requirements for statewide voluntary preschool. SF592 will allow 5 year olds for statewide voluntary preschool and changes, it also changes the age restriction timeline. HF275 that would allow allowable growth on ECI funds did not make the funnel.

New MCO

On July 1, 2019, Iowa Total Care, Iowa's new Managed Care Organization (MCO) will begin providing services to Medicaid members. Most members will be receiving letters assigning them to one of the three MCOs (Amerigroup, United Healthcare, and Iowa Total Care). Members may soon be assigned to an MCO different from the one to with which they are currently involved. However, if they so choose, the member may elect to stay with their current MCO. Members will have until June 18, 2019 to contact Iowa Medicaid Enterprise (IME) member services to change their assigned MCO. Members may also change MCOs for any reason until September 30, 2019.

The American Lung Association holds the Community Partnership grant funded by the Iowa Department of Public Health, Division of Tobacco Use Prevention & Control for eight counties in Iowa. We serve Adair, Dallas, Jasper, Madison, Marshall, Polk, Union, and Warren Counties and follow best practices for tobacco control outline by the CDC:

- 1. Prevent the Initiation of tobacco use among young people
- 2. Eliminate non-smokers exposure to secondhand smoke
- 3. Promote quitting among young people and adults
- 4. Identify and eliminate tobacco-related disparities among population groups.

FY2019 Initiatives for Adair County

Tobacco-free Worksites: 1/1 – Met Goal

- ✓ Staff mailed a survey to 204 worksites (21 responses).
- ✓ Follow-up mailed to businesses who participated in the survey.
- ✓ Schroeder Family Dental updated policy to Tobacco-Free and Nicotine-Free.
- ✓ 8 dropoffs to businesses
- ✓ Staff spoke at the Healthy Hometown meeting about Quitline Iowa and resources
- ✓ We are dropping off letters (with resources and posters) to each middle and high school in our counties
 - o Will also follow up with the principals
- ✓ Iowa Youth Survey 2018 (IYS 2018) data was just released
 - Only state data is available at this time. County data will be available at a later time.
 - o Current use of Cigarettes:
 - 6% of 11th graders use cigarettes
 - 2% of 8th graders use cigarettes 1% of 6th graders use cigarettes
 - Current use of E-cigarettes:

22% of 11th graders currently use E-cigs
