Crossroads Behavioral Health with a subcontract to Zion Recovery is the new agency for substance abuse prevention in Madison County effective January 1, 2019. Jodi Haley provided an overview of the areas of focus with the grant - alcohol, marijuana, tobacco, gabling, and prescription drugs and serves the full spectrum of population 0-99. Zion is currently looking to fill positions for prevention specialists.

- Tallie provided an update regarding Nurturing Healthy Sexual Development. Three training sessions have been scheduled for March 23 from 4:30-6:00, April 18 from 4:30-6:30 and May 7 from 6:00-8:00 all to be held at the Winterset Library. The goal is to provide 15 sessions and 75 adults to be served by June 30th. Tallie reported that all of the youth sessions and children served have been met.
