#### **Special Presentation: Dallas County Sherriff**

New/ongoing trends in Dallas County (regarding juveniles/families – substance abuse and mental health)

Juveniles -

- Vaping pens are not being used as much for tobacco anymore (as company intended) as it is for 'dabbing' and marijuana
- All eight school districts have contact the Dallas County Sheriff's Office (DCSO) regarding the high numbers of vaping
- Social media is still a huge concern regarding cyberbullying in general and cyberbullying resulting in suicides
- Continue sexting issues and dissemination
- 21 sexual assaults reported in the last 24 months
- 10 child abuse cases in the last 12 months
- Dallas County Communications (Dispatch) received 18,000 calls for service last year (excluded the cities of Perry and Waukee)
- At home is where all is taught and where it starts. Parents are defending their children's actions/behaviors which is a huge part of the issue

Adults -

- Mental health services are still being provided in the jail at the DCSO (Jail Diversion) through Heart of Iowa Region Community Services. Many inmates on prescription medications (at least 60%)
- More contraband is being smuggled in because of no more strip search law
- DCSO Patrol: High amounts of marijuana, methamphetamine and heroin (the latter for women)
- New DCSO jail will be completed by early November 2019 and will hold approximately 160 inmates and will also hold inmates for surrounding counties that are over-crowded
- Would like to get more Dallas County agencies to speak/hold mini-trainings to the inmates for appropriate services (housing, veterans, financial literacy, etc)

#### **Agency Sharing**

- Partners in Family Development (PFD): Jovanka advised members that Parents As Teachers has that curriculum in three additional languages beyond English for parent/family support
- PFD: Another Parent Café was just held in Perry. Advisement/reminder that PFD offers Parent Café, Dad's Café, Vitality Café, 24/7 Dads and Inside Out Dad Café
- PFD: PFD's Perry Office is relocating from the current location in Perry to the Perry Chamber building, which means PFD will be down-sizing and office supplies will be available to other agencies if needed/garage sale
- Four Oaks: Mindy advised members to register for the Lunch-and-Learn at after next Coalition in May {flyer}
- American Lung Association{report handout}Samra Hiros with the American Lung Association provided Quarter 4 action plan updates. Staff met the worksite policy goal for Dallas county for this fiscal year. Samra dropped off E-cigarette resources and posters to all Dallas middle and high schools. Staff has a meeting scheduled at ADM middle school to potentially start an ISTEP chapter. Staff updated the coalition on the recent Quitline Facebook ad that ran. Samra also

### STATE DATA CENTER: DALLAS COUNTY AMONG TOP TEN FASTEST GROWING NATIONWIDE

**DES MOINES**— Dallas County is among the top ten fastest growing counties in the nation according to new county and metropolitan statistical area population estimates for 2018 from the State Data Center via the U.S. Census Bureau. The county ranked as 8<sup>th</sup> fastest nationwide, with an increase in population of more than 36 percent, or 90,180 people, since 2010.

After Dallas County, the fastest growing counties in Iowa were Johnson, with a 15.6 percent increase in population, and Polk, adding 56,572 people- the most statewide- and growing 13.1 percent since 2010.

The estimates continue the trend of growth in and around the major cities of the state. "Iowa's population growth over the last decade has been centered around metropolitan counties," said Gary Krob, State Data Center Coordinator. "Most of the 30 counties that have seen growth since 2010 are either part of a metropolitan area or are adjacent to one."

More than half of the state population (52.8 percent) lives in one of 10 counties, all part of a metropolitan statistical area, which include Polk, Linn, Scott, Johnson, Black Hawk, Woodbury, Story, Dubuque, Pottawattamie, and Dallas counties.

For metropolitan statistical areas, the Des Moines-West Des Moines Metro Area was the fastest growing in Iowa since 2010 with a growth of 15.1 percent; followed by Iowa City Metro Area at 13.6 percent; and Ames Metro Area at 9.6 percent growth.

Clinton was one of 69 counties in Iowa that have lost population since 2010 and had the highest decline, losing 2,599 people; while Emmett County declined at the fastest rate, losing 10.2 percent of its population. A loss in net migration occurred in 80 Iowa counties, where more people moved out of the county than in.

The new county, metropolitan, and micropolitan population estimates, rankings, and maps are available on the State Data Center website at www.lowaDataCenter.org.

These new estimates from the Census Bureau are based on administrative data for births and deaths and estimates of migration since the 2010 census. Caution is urged in making year-to-year comparisons of population estimates. When the Census Bureau releases new estimates for the current year it also revises estimates for previous years in the decade.

The U.S. Census Bureau Population Estimates Program prepared the latest population estimates in partnership with the Federal-State Cooperative Program for Population Estimates. The State Data Center is part of the State Library of Iowa and is a member of the Federal-State Cooperative Program for Population Estimates.

#### Structure/Flow Chart of Child Abuse Prevention Services

#### Iowa Department of Human Services (IDHS)

The State Legislature established the Iowa Child Abuse Prevention Program (ICAPP) in 1982.

IDHS issues a request for proposal to address primary and secondary prevention services intended to increase protective factors, making children, families, and communities safer and more resilient.

Projects that receive ICAPP funding must address services the following types:

(1)family Support, (2) crisis care, (3) sexual abuse prevention and/or (4) community development.

IDHS issues state of Iowa contracts to local Community-Based Volunteer Coalitions or Councils as well as makes payments to local Coalitions or Councils.

#### Prevent Child Abuse Iowa (PCA)

PCA is the entity, contracted by IDHS, to provide administrative support services for ICAPP.

PCA monitors all local ICAPP contracts issued to Community-Based Volunteer Coalitions or Councils.

PCA monitors Community-Based Volunteer Coalition or Council contract deliverables and reviews payments that are to be made to Coalitions or Councils.

#### Community-Based Volunteer Coalition or Council

Only Community Partnerships for Protecting Children Coalitions (CPPC) or Child Abuse Prevention Councils are eligible to apply for ICAPP funding. When funding is granted, the Coalition or Council may contract with a local service agency to provide one or more of the service types list above. The Coalition or Council is the contractor holder for the ICAPP funds and is responsible for contract deliverables, funding reimbursements, and other grant requirements.

#### **Local Human Service Agencies**

Subcontracts may be issued to local human service agencies to deliver one or more the required service types. The human service agency is required to meet deliverables in the Coalition or Council contract with IDHS.

Subcontract to local agencies are as follows: Adair County - Southwestern Community College Dallas County - Crisis Intervention & Advocacy Madison County - Crisis Intervention & Advocacy
