Staff is planning to present to Nodaway High School and Middle School students, and at this time is working on scheduling presentations. Staff also met with Zion Recovery Services to discuss Quitline Iowa and the referral process. Staff ran a Quitline Iowa ad in the Adair County Free Press in the month of March. Samra notified the coalition that Prior-Authorizations are going to be removed for Nicotine Replacement Therapies for MCO and fee-for-service patients. More info to come on this change. ## Legislative Update

Deb shared information on several bills. <u>SF304</u> - an Act relating to licensing sanctions against individuals who default or are delinquent on student loan debt or on a related service obligation. This was signed into law April 8th by Governor Reynolds. <u>HF758</u> - this is the Iowa House education appropriations bill that has passed the Iowa House and provides for \$1 million increase for ECI. The Iowa Senate version of the education appropriations bill is different than the Iowa House and they are \$15 million difference.

## **Toddlerfest**

The Adair County Toddlerfest will be April 15, 2019 from 5:00-7:00 at the Nodaway Valley Elementary School. 4 R Kids has allocated \$500 for expenses and a \$950 mini grant from CPPC was awarded to support the event. The event is organized by SWCC.
