Introductions

Library Resources - Some libraries in Iowa provide a service through Kanopy where you can download 10 videos free of charge. It was also discovered that some libraries offer free passes to different venues, such as the Zoo and Science Center.

4 R Kids ECI Board -The board is looking for board members, there is an application at www.4rkids-eci.org for anyone who is interested. The 4 R Kids ECI board will be reviewing indicators and input was sought from the group regarding eliminating the unemployment indicator and adding parents in workforce with children under 6. This is more representative and aligns with the goals of the board. It was consensus to recommend this change to the board.

Preschool Experience Data- Deb shared the data collected from all school districts in Adair, Dallas, Madison and Warren county regarding the preschool experience rate. The average for the four counties was 84.3% and the 4 R Kids goal is 90%. The lowest preschool experience rate by school district was 64.9% and the highest was 100% from five school districts.

Assessment - Early Childhood Iowa has completed a statewide needs assessment. Access to child care was the most significant concern for parents as well as providers.

Project Launch - IDPH has received a SAMHSA federal grant of \$3,821,013 over 5 years to address behavioral health issues with children under the age of 8. Drake University Head Start will be a recipient of the grant and is in the process of hiring two therapists and one family engagement specialist. The grant is also to address infant and early childhood mental health in Iowa.
