
# Warren County Early Childhood Committee

# **Warren County Health Services Updates**

- 1<sup>st</sup> Five has seen a drastic drop in new referrals; 3 received in April. 1<sup>st</sup> Five is able to receive new referral from medical providers and is connecting families as services are available.

- Spring 2020 Warren County Newsletter was sent out with articles from all our staff (attached)
- Warren County Health Services has staff able to complete Presumptive Eligibility Insurance for children birth to 17 and pregnant women over the phone.

### **Child Care Survey**

Lora Patton provided a presentation on the child care survey due to Covid-19. Providers estimate from \$5,000-\$10,000 was lost in revenue, some responded as high as \$40,000; 55% of providers said they had openings; 94% of providers indicated they have experienced a financial loss; a few providers indicated challenges with the food program due to strict guidelines; obtaining needed supplies to run their program has been challenging (cleaning supplies thermometers, etc).
