- Agenda accepted
- Last month's minutes accepted and filed
- Subgroup Updates:
 - 4 R Kids Early Childhood Committee (Debra Schrader)
 - The 4 R Kids ECI area board will release an RFP for FY22 with the option of renewal for 2 additional years. The purpose of the funds is to support families with children under the age of 5 and must adhere to the required state service types. Release date is March 12, 2021 and due April 16, 2021, information will be posted on the 4 R Kids website.
 - Several legislative bills and other matters were reviewed; many bills are around child care. A list of bills of interest are located in Google Drive.
 - 2019 Medicaid births were reviewed, Warren County has a rate of 24.6%, the state rate is 40.6%, the highest rate is Woodbury County at 63.2% and Lyon County is the lowest at 13.4%.

Member Updates:

- Betsy Stursma
 - There is an exciting new service available to the CICS region (Hamilton, Hardin, Franklin, Greene, Boone, Story, Marshall, Warren, Madison, Jasper, and Poweshiek counties). In coordination with CICS and ITP, UnityPoint Health Eyerly Ball began offering CSCBS services on Monday, January 18th. CSCBS is another Chapter 24 service that will go hand-in-hand with our current Mobile Crisis service, and it stands for Crisis Stabilization Community Based Services.
 - To give a very brief overview, this is a very intensive and short-term crisis service available free of charge to anyone within the region. Eligible individuals will have daily contact with a licensed mental health professional and case manager, in addition to having access to medication management, peer support, and skill building services over the course of five days. These services will be provided to the individual in a safe and secure location within their own community. If an individual has Medicaid, insurance will be billed for the service, though any individual with any service is eligible to receive these services at no cost.
 - CSCBS services can be initiated 24/7 by contacting the Your Life Iowa crisis line at 855-581-8111. A Mobile Crisis team will be dispatched to the individual's location to perform an assessment and complete a referral if deemed appropriate. Within two hours of receiving a referral, an on-call therapist will contact the individual to conduct an eligibility assessment for CSCBS services. By the end of that assessment, a client will know to expect a phone call from either CSCBS or MCRT case managers the following day (depending on eligibility).
 - Attached is a CSCBS flyer please feel free to share this information with anyone who may benefit!
 - Also, CICS is working with the other Regions across the State and Brain Health Iowa (brainhealth-now.org) to promote a new website: https://iowamhdsregions.org/ to help individuals find mental health help close to home and reduce stigma. We are also doing a marketing campaign both at the state level and for CICS to reach more individuals to let them know about the mental health services that are available.
