## Coalition Updates:

- Agenda accepted
- Last month's minutes accepted and filed
- Subgroup Updates:
  - 4 R Kids Early Childhood Committee (Debra Schrader)
    - HF 868, the Education Appropriations Bill passed both the House and the Senate and was sent on May 19, 2021 to the Governor to await her signature. She has 30 days to sign it or veto it.
    - Based on the work of Association they were excited to announce that it contains
      a funding increase of 2.4% the same percentage received by the K-12 system this
      year. It amounts to a total increase of \$546,000, this is the largest increase in
      funding to Early Childhood Iowa since FY 2007. This amounts to about \$26,000 to
      the 4 R Kids ECI area. Additionally, the bill raises the school ready administration
      cap from 3% to 5%. On top of that the bill eliminates the funding estimate

portion of the fiscal assessment in the community planning process. All the details are in the attached amendment.
