  - 4 R Kids Early Childhood Committee (Debra Schrader)
    - Lead: Deb Schrader (4rkidseci@gmail.com)
      - Iowa Kids Count data has been released and low birth weight is a concern; it has increased by 66% since 2000 and is in the 10 counties in Iowa for concern.
      - The 4 R Kids ECI area is in the process of collecting preschool experience data from school districts. Preliminary data suggests that 84% of kindergartners had a preschool experience, more information will be available soon.
      - The Governor is having a Press Conference the same time of this meeting, she will unveil her child care plan at that time.
      - There was a special legislative session in which the Iowa legislature changed the congressional districts, house and senate districts due to the U.S. Census. New maps are available on the legislative website.
