- 2 4 R Kids Early Childhood Committee Update(Debra Schrader)
 - Lead: Deb Schrader (4rkidseci@gmail.com)
 - Deb shared legislative bills that are still active, 3 child care bills, daylight savings bill, and pizza dough roller bill.
 - DHS is providing recruitment and retention bonuses for child care centers and child development homes, every 6 months until the federal Covid relief funds run out.
 - The FY20 Medicaid births were reviewed, Warren County's rate is 22.8% and the highest in the state is 63.9% in Wapello County and lowest in the state is Delaware County at 18.7%.
 - The 4 R Kids Board has a full board with 12 members, three from each county.
 - Data from the Federal Bureau of Investigation was shared, Aggregated assault rate has increased in Iowa from 2019 to 2020 to 213.1 to 229.4 per 100,000 people and violent crime increased from 287.6 to 303.5 per 100,000. The United States also increased.
