 - 2021 child abuse data was shared; there were 409 child abuse reports of which 313 were abused; 51% of the 313 were under the age of 5.
 - lowa Total Care has a language line that can be utilized with members when scheduling medical appointments.
 - Bills of interest were shared; 16- & 17-year-olds can watch child unsupervised; 16 & 17 are exempt from finger prints; child ratio for 3 & 4 years will increase; the MOMs bill is modeled after Texas which expands Medicaid for 12 months post partum and adding \$1 million for additional support.

- The Mobile Crisis Response Team responded to six calls in Warren County in March. This is a free service available 24/7 to all ages and can be accessed by calling the Your Life lowa crisis line at 1-855-581-8111. Within 24 hours of the crisis call, a case manager will follow up with the individual and is available to provide assistance for up to 30 days. We want this service to be utilized to its highest potential, so if you or anyone you know may want rack cards, crisis cards, or a quick presentation, feel free to reach out! monicav@eyerlyball.org
- o The Crisis Stabilization Community Base Services (CSCBS) team did not receive any referrals in Warren County in March. In short, this is an add-on service to Mobile Crisis that is available to all ages and is also free of charge. Clients in this short-term stabilization program receive hour-long in-person visits from a case manager for five days in addition to daily virtual visits from a mental health professional during those five days. Clients also have the option to utilize medication management and peer support services during the course of the program. Good candidates for this service are individuals who need immediate stabilization at a higher level than traditional case management services but who would not meet criteria for inpatient hospitalization. - Eyerly Ball also has a free Youth Mental Health First Aid training coming up. This training will be held on Tuesday, April 26th from 9am-4:30pm and will be held virtually. To register, email training@eyerlyball.org
- Gabbie Ruggiero, Employee & Family Resources, State Opioid Response Grant Coordinator:
 - Multiple doses of NARCAN, the opioid overdose reversal drug, can now be ordered for free directly through IDPH for any business interested in training their employees on its use and having it as a part of their first aid kit. Trainings can be short—around 20 minutes—and can easily be integrated into a staff meeting. With the rise in opioid-laced

- recreational drugs, organizations like the Red Cross now integrate NARCAN training and overdose response into general first aid courses. Using NARCAN is easy and can save a life.
- Treatment and prevention folks are hearing more reports of fentanyl, a potent opioid, being laced in fake prescription pills, marijuana, and vape cartridges in Iowa. If you work with folks that use drugs, this is important information to share. Anyone in Iowa can get NARCAN without a prescription. Please reach out for more information on this. I'm happy to come to your organization and/or work with your clients to discuss this topic and overdose prevention.
