 - An organizational chart for the new Health and Human Services was shared with the group. Early Childhood Iowa falls under Family-Wellbeing and Protection in the Child Protection Services section. It is unclear how this will impact ECI if any.
 - The 2022 Health Rankings were shared, Warren County ranks fairly high in most areas and ranks 17th out of 99 counties in Iowa for overall health outcomes. The previous vear's rank was 10.
 - Data from DHS on QRS ratings were shared, Warren County has 50% of child care providers in the state that have a QRS rating, the state average is 35.6%. Warren County has been consistent in QRS higher than average rankings over the years.
