Announcements and Agency Updates

- **Zion** - Lisa updated the group that she has completed teaching the LifeSkills Curriculum in both the Orient-Macksburg and Nodaway Valley school districts to move the youth tobacco use strategy forward for the IPN grant. She is also hopeful to be able to implement the Generation Rx Curriculum to groups 65+ soon for the adult prescription misuse strategy. If anyone has an interest in this service, please let her know. As for the problem gambling strategy, they have implemented the Responsible Gambling Toolkit with all 11 lottery vendors in Adair County and continuing to promote the Be #1 at Getting Help campaign.
- **American Lung Association**- Staff shared Q4 tobacco control update. The update highlighted the smokefree homes registry for the group to refer to when looking for smoke free homes. Staff also shared policy change efforts with the group. If anyone would like to meet to discuss tobacco control efforts in Adair County, or ways we can partner for upcoming events, contact Reshana at reshana.vandeuren@lung.org.
- **Greenfield Public Library** - is providing outreach services and delivery to homebound.
- **DCAT/CPPC** – There are mini grants available for up to \$950 that addresses one or more of the CPPC strategies. Love and Logic classes are currently going at SWCC. Parent Cafes will be offered in April.
- **CCRR** - There will be CCRR listening sessions to help shape the next five years for child care services. A session will be held at 5:00 at SWCC on April 25, 2023.
- **Child Care Assistance** - State child care assistance program has \$28 million unallocated and return to the federal government.

- Treasures Report – The bank balance is \$2,503.37. A few bills remain to be paid.
- Sharon Miller will be the new Prevent Child Abuse Iowa director.
- To date 25 people have been served and 4 sessions provided.
- Child Abuse Prevention Awareness – Pinwheel vases have distributed to the local libraries and 3 articles will be sent to the local news papers. The child abuse prevention proclamation has been signed by the Board of Supervisors, Tammy Ewing and Val Cameron attended the signing.
- CIAC has funding for anyone wanting to attend the Child Abuse Prevention conference May 9-10th.

Early Childhood Committee

- 4 R Kids Board – There is an opening on the board for a Dallas and Warren County representatives.
- The FY24 request for renewal applications have been issued to current contractors.
- Legislation – Several bills were reviewed.
- HHS alignment – Ann Lebo has replaced Shanell Wagler. The DHS service areas have changed, Adair County is now in the Western DHS service area effective July 1, 2023.
- The FY23 County Health Rankings were shared with the group, Adair County ranks 52nd overall within 99 Counties.
