Agenda (Action)

Board member Hopkins moved to approve the November 16, 2023 agenda. Board member Reaman-Gerdes seconded. Motion carried unanimously.

Minutes (Action)

Board member Hanson moved to approve the September 14 ,2023 minutes. Board member Al-Mazora seconded. Motion carried unanimously.

Board Membership Recruitment and Retention (Information)

Board members continue with recruitment efforts and strive for gender balance. The board has a range of board members from eight to twelve. There is one position open on the board for Dallas County. Board member retention will remain a focus.

Annual Board Performance (Information)

Director Schrader announced that the annual board performance review will be conducted in December and a survey link will be sent to board members. Additionally, the community will also conduct a performance review of the board. It was noted this is not a requirement of local ECI boards, however it is best practice.

Health and Human Services Alignment (Information)

Director Schrader provided an update on the HHS alignment. As stated on the HHS website the recommendations regarding the redesign of ECI and several other programs were to be provided in October, to date the recommendations have not been released.

Association of Early Childhood Iowa Area Boards and Advocates (Information)

The FY24 legislative agenda was reviewed along with the FY23 annual report. Board Member Martens attended the conference and was a guest speaker at the conference. Director Schrader also attended the statewide conference on November 9, 2023 in Des Moines and assisted with the conference details.

Additional Funding Request (Action)

Board member Al-Mazora moved to approve a funding request of \$3,500.00 for Short Years Partnership to purchase of technology upgrades. Board member Hopkins seconded. Motion carried unanimously.

Finance Committee (Action)

The Finance Committee members reviewed budgets, payment vouchers, bank statements, and fund balance reconciliations prior to the board meeting. Board member Hopkins moved to approve the September and October 2023 expenditures in the amount of \$100,177.09 and \$129,176.92 respectively. Board member Petter seconded. Motion carried unanimously. It was noted the rate of spending for FY24 was 24.7% of school ready funding and 25.5% of early childhood funding, on target spending is 35%.

Board Program and Service Committee (Information)

The Committee met October 27, 2023 at 9:00 by Zoom. Supporting documentation from the Program and Service Committee was provided. The committee reviewed the 1st quarter progress reports from the contractors and there were no fiscal or programmatic concerns and spending is on target.
