Agency and Other Information

- Carstens, Certified Prevention Specialist at ZION Integrated Behavioral Health Services. Lisa shared with the group she taught the Prime for Life 420 Curriculum to 8th graders at West Central Valley Middle School (Redfield) in October. They are still seeking other schools in Dallas County that would be interested in either Prime for Life 420 (marijuana priority area) or LifeSkills Curriculum (tobacco priority area) yet this fall or in the spring. As for the gambling priority area, Lisa reminded the group of the Be #1 at Getting Help Media Campaign that ZION is promoting. This campaign has a sports betting emphasis and also promotes 1-800-BETSOFF. She also provided posters and magnets that people could take back to their agencies/businesses if interested.
- Reshana VanDeuren, American Lung Association, shared the Quarter 2 update for Dallas County. The update included tobacco control updates for tobacco and nicotine free policies, youth vaping education, and tobacco cessation resources. - Information was provided on the EveryStep Nest Program, Dallas County parents will need to travel to Polk County to receive services and meet income guidelines.
- Opioid death data in Iowa was provided to the group.
