### **Agency and Other Information**

- American Lung Association Staff shared the FY25 tobacco control goals and initiatives in Dallas County. Staff is working on youth tobacco programming, community education, tobacco policy change, and providing Quitline Iowa resources with community members. Please reach out to <a href="Reshana.vandeuren@lung.org">Reshana.vandeuren@lung.org</a> to further discuss tobacco/nicotine resources and support. Also there is a new tobacco product called ZYN.
- CCRR There has been a rebranding of CCRR.
- New Opps Low-income energy assistance is available; a family of 4 making \$62,400 may qualify.
- Every Step Information was shared about Medicaid; income requirements and exceptions were also shared. It was noted that hospitals can request emergency Medicaid funding for up to 3 days of emergency care if the person is not insured.

#### Early Childhood Updates/Information

- The 4 R Kids Board has Dallas, Adair and Warren County positions open on the board.
- There will be 2 constitutional amendments on the November 5<sup>th</sup> ballot.
- A list of legislative candidates was provided.
- Free mental health counseling is available with the University of Iowa's telepsychology.
- An update on Thrive pilots was provided along with a one-page document; CRISP in Madison and County and Warren Count Public Health will be the 2 pilots for FY25.
- CCRR data was provided by Michelle Greenough.
- The Iowa Infant and Early Childhood Mental Health summit is October 25 from 8:00-2:00, its online and free.
- 2023 death rate and birth rates was provided. Dallas County 632 deaths and 1,382 births.

# Dallas County Children's Advocacy Council Updates/Information

- The Prevent Child Abuse conference next year will be April 29-30, 2025.
- An update on programming 1st quarter reported was shared.
- The checking account balance is \$2,819.62.
