Early Childhood Updates/Information

- The 4 R ECI board has two new board members, Ricki Hall and Jovanka Westbrook.
- HHS has provided \$90,773 to the 4 R Kids board to continue with Thrive Iowa in Warren County but only through December 2025.
- The family support map was reviewed and changes made where necessary.
- The early childhood services map was reviewed and changes made where necessary.
- Medicaid birth data was reviewed: Dallas County had a 17.2% Medicaid rate.
- The HHS District 5 opioid brief data was shared. There is a brief for all 7 districts
- Dental Quest will be a new dental provider for Medicaid recipients starting July 1, 2026.

Dallas County Children's Advocacy Council Updates/Information

- An update on FY26 programming was provided; 1 presentation with 15 people were served in the 1st quarter.
- Information was provided regarding the technical assistance call on 9/22/25. There will be a contract amendment due to HHS not clarifying the due date of quarterly reports in the contracts.
- 1st quarter report is due October 15th or the 30th.
- August 2025 expenditures have been submitted via Iowa Grants; \$3,246.04 for home visitation and \$2,6923.55 for sexual abuse prevention.
- The Council has a new treasurer Heidi Chapman effective today 9/24/25.
- The executive committee will have quarterly meetings. Executive committee members are Susan Crowdes, Heidi Chapman, Barb Ranck and Stephane Claussen.
- Connections Matter facilitator training will be September 29-30, 2025.
- Val Cameron continues to facilitate aspects of the grant.
